Set up and tear down instructions will be provided for each event. Vehicles are not allowed in the vendor area and must be parked in a different location.
Vendors will be given their location during check-in on the date of the event. Due to the varying nature of each event, vendor locations may be changed.
Food Vendors must supply all equipment necessary for operation including trash receptacles, tables chairs, tents, leveling items and quiet run generators (under 75 decibels). Ground stakes are not allowed and all tents must be secured with proper ground weights as needed. Any generator deemed too loud o unsafe will not be allowed to operate. Power will be provided for retail vendors at the venue.
All cooking oils, grease, etc. must be captured and contained so they do not drip, spill, or otherwiso distribute on the grounds of the venue. All cooking grease/oils must be disposed of off-site and no poured down gutters or drains or placed in the trashcans.
Any vendor distributing food items must follow all guidelines enacted by the Hopkins County Healtl Department.
It is the Vendor's responsibility to obtain any and all necessary permits, license, etc. as required by local, state or federal law. This including a 2024 City of Madisonville business license if applicable. Vendors <u>MUST</u> remain current or will not be allowed to set up.
